## 2026 BYLAW CHANGE PROCEDURES

State Committeemen interested in submitting a Bylaw Change for the 2026 Mandatory Meeting must send their drafts to [Bylaws2026@azgop.com](mailto:Bylaws2026@azgop.com) no later than WEDNESDAY, DECEMBER 10, 2025, at 11:59 PM Phoenix time.

Bylaw Changes for the 2026 Mandatory Meeting must meet the following criteria per the Continuing Bylaws of the Republican Party of Arizona:

### **B. Method of Amending Bylaws**

An amendment to these bylaws may be proposed at any meeting called in accordance with these bylaws. A copy of the proposed amendment together with a statement explaining the purpose to be achieved and the reasons in support thereof shall be sent to each member by the secretary with the notice of call for that meeting as prescribed in Article III – MEETINGS.1 Notice. A two-thirds vote of the members present in person or by proxy shall be necessary to pass any motion to amend.

### **C. Applicability of Bylaws**

These bylaws apply fully to the county committees of the Republican Party of Arizona. County bylaws may not conflict with these bylaws.

### **D. Compliance with State Law**

These bylaws may not conflict with Arizona State law as set forth in the Arizona Revised Statutes
