**PROPOSED RESOLUTION 1**

**Submitted by: Walter Dempsey (Coconino County)**

**Status in Committee: MOTION MADE AND PASSED 0-17-0**

**COMBINE RESOLUTION 1 AND RESOLUTION 5 TO CREATE RESOLUTION 8**

**RESOLUTION TITLE: Election Integrity**

**RESOLUTION:**

WHEREAS, President Donald J. Trump has wisely called for election integrity; and

WHEREAS, the below-signed LD 6 and 7 State Committeemen believe that election integrity is fundamental to safeguarding our constitutional republic and stand with President Trump's call to secure our elections and are committed to supporting Legislators who fully embrace election integrity.

NOW, THEREFORE, BE IT RESOLVED that the below-signed Legislative District 6 and 7 State Committeemen hereby declare their support for Legislators committed to the following actions:

Prioritizing Election Integrity Legislation

Supporting the Conduct of Legislative Hearings When Election Irregularities are Suspected: Investigating election irregularities and using subpoena authority to forward criminal cases to the Arizona Attorney General for prosecution.

Calling for the Elimination of Voting Machines and Software: Supporting the exclusive use of hand-marked ballots, hand-counted at secure, observable government-approved locations.

Calling for the Restricted and Secure Use of Mail-in Ballots: Limited exceptions to include U.S. Military and Federal employees stationed outside of Arizona during elections; persons with significant health infirmities; those protected by the Americans with Disabilities Act; Tribal government-recognized members, unable to travel due to isolated location.

Mail-in ballots must be received by 11:59 PM on Election Day.

Calling for Smaller Precinct-voting, Counted and Accounted for on Election Day: Capping at 1000 registered voters per precinct.

BE IT FURTHER RESOLVED that the below-signed LD 6 and 7 State Committeemen call upon all elected officials to uphold these principles to ensure public trust in Arizona's electoral processes and preserve the integrity of our Republic.

**PROPOSED RESOLUTION 2**

**Submitted by: Daniel Dellinges (Santa Cruz County)**

**Status in Committee: FAILED 0-14-3**

**RESOLUTION TITLE: Legislative District Realignment**

**RESOLUTION:**

This is a request for consideration to recommend to the Arizona State Legislature a realignment of legislative districts to represent the State counties and follow the constitutional requirements of a representative republic form of government. Arizona has 15 counties. This is a unique position and presents an opportunity. The recommendation is to eliminate the census and gerrymandering conflicts that cause so much infighting. Each county legislative district will have four representatives and two senators. This will negate the movement towards breaking up counties believed to be too large, as each county has its own unique characteristics.

**PROPOSED RESOLUTION 2 CONTINUED:**

This proposal will distribute the state's legislative power equally over all counties. This recommendation does require a major legislative effort and will require an amendment to the state constitution. The redistricting of each independent county will provide additional challenges. There will be no need for state committeemen as the precinct committeemen will provide that function. An additional resolution will establish an electoral college format that will elect the state party executive boards. This resolution is intended to be non-partisan. The current system is not working well. There is too much infighting. My recommendation is only a beginning – make yours.

**PROPOSED RESOLUTION 3**

**Status in Committee: FAILED 2-14-1**

**RESOLUTION TITLE: AZGOP to AZLeg: Just Say "NO" to Crypto**

**RESOLUTION:**

Whereas "Cryptocurrency" is defined by Webster's Dictionary as "any form of currency that only exists digitally, usually has no central issuing or regulating authority, uses a decentralized system to record transactions and manage the issuance of new units, and is dependent upon cryptography to prevent counterfeiting and fraudulent transactions";

Whereas the similarities between government-regulated Black Box Voting Machines and government-regulated Cryptocurrency are most concerning;

Whereas it is important We The People's Elections return to REAL Election Integrity: eliminating Black Box Voting Machines and returning to openly and transparently hand counting pre-printed physical paper ballots — electoral "assets" physically seen, touched, and plainly understood;

Whereas a wide-ranging multitude of "grave" Cryptocurrency concerns are self-evident: based upon an artificial digital construct, extremely volatile, minimal consumer protection, irreversible transactions, prevalence of fraud and scams, security vulnerabilities, regulatory uncertainty, lack of intrinsic value — Crypto is the fiat of fiat currency — "fiat" meaning "because I say so";

Whereas, "Why would a government once based upon a Gold Standard — now the Dollar — simultaneously hype up Crypto while downplaying the Dollar's most realistic and strongest competitor — Gold — as central banks stockpile Gold reserves?"; and

Whereas physical Gold and Silver — established since antiquity as "Natural Law Currency" — both store REAL intrinsic value; now therefore be it Resolved, that the AZGOP hereby urges the Arizona State Legislature:

- 1) stop drafting superficial, hyped-up, trendy, and controversial Cryptocurrency bills, and
- 2) return its attention to addressing — and safeguarding — We The People's REAL interests: REAL Election Integrity and REAL Money.

**PROPOSED RESOLUTION 4**

**Status in Committee: FAILED 0-17-0**

**RESOLUTION TITLE: Reorganization of County Committees**

**RESOLUTION:**

This is a recommendation for consideration: a change to the organization of the Arizona State and County Committeeman. This is intended to compliment the resolution put forward regarding constitutional changes to the legislative district format. The recommendation is to take advantage of Arizona's unique position of having 15 counties. Each county has its own unique character, and as such should be independent of other counties. Each county should be able to operate their party committees independently, but within the county. The precinct committeemen should continue to elect their executive board.

**PROPOSED RESOLUTION 4 CONTINUED:**

It is further recommended that a portion of that elected board – Chairman, 1st Vice Chair, and the 2nd Vice Chair – will then act as the electoral college representatives to elect the state party executive board. This recommendation serves several purposes. One; it removes the need for State Committeemen. Two; it levels the field of power and distributes that power equally among all 15 counties. No longer will it be felt necessary to split a county believed to be too large. Three: it removes the threat that a single or small combination of counties can hold sway over the entire state. Four: Those wishing to represent the entire state will then have to actively engage all 15 counties for support. These recommendations follow the Arizona State Constitution requiring that our form of governance follow a representative republic model. Five: it removes most of the infighting that plagues our organization. Working together we can make it happen.

**PROPOSED RESOLUTION 5**

**Status in Committee: MOTION MADE AND PASSED 0-17-0**

**COMBINE RESOLUTION 1 AND RESOLUTION 5 TO CREATE RESOLUTION 8**

**RESOLUTION TITLE: Resolution to Restore Election Integrity in all State and Federal Elections held in Arizona Statewide**

**RESOLUTION:**

WHEREAS, public confidence in Arizona's elections has been weakened by electronic voting systems, generic voting centers, and prolonged counting delays; and

WHEREAS, the use of paper ballots, each containing a unique, sequential serial number, provides clear chain-of-custody; and

WHEREAS, hand counting of paper ballots at the precinct immediately after polls close is the simplest, most transparent, and most fraud-resistant method of vote tabulation; and

WHEREAS, prolonged ballot-counting timelines undermine public confidence in election outcomes and create opportunities for uncertainty, error, or manipulation;

THEREFORE, BE IT RESOLVED, that the Arizona Republican Party calls for the elimination of generic voting centers and the restoration of precinct-only voting for all elections in Arizona; and

BE IT FURTHER RESOLVED, that all ballots in Arizona elections shall be counted by hand at the precinct level immediately after polls close, precincts publicly reporting their final hand-counted tallies no later than 10:00 a.m. the following morning; and

BE IT FURTHER RESOLVED, that any precinct or county failing to meet the deadline shall have its election declared invalid, and shall be required to conduct a prompt and lawful new election; and

BE IT FINALLY RESOLVED, that this resolution shall be transmitted to all members of the Arizona Legislature, the Governor, the Secretary of State, and county Board of Supervisors with the expectation that legislation and administrative rules be adopted to implement these standards immediately.

**PROPOSED RESOLUTION 6**

**RESOLUTION TITLE: Thank You, Charlie Kirk**

**RESOLUTION:**

Whereas Charlie Kirk played a great and uniquely special role in providing an overall principled, patriotic, and humanitarian service to the United States of America, the America First Movement, and American Civil Society; now therefore be it Resolved, that the AZGOP hereby expresses its profound and sincere appreciation, admiration, and gratitude to Charlie Kirk.

**PROPOSED RESOLUTION 7**

**RESOLUTION TITLE: AZGOP Promotes Long-Standing Principle Mandating Only U.S. Citizens Eligible and Qualified for Elective Office, Precinct Committeeman, and State Committeeman**

**RESOLUTION:**

Whereas it is basic common sense that a Citizen possesses only one Citizenship and only one corresponding Oath of Allegiance for only one Nation at a time;

Whereas in running for Elective Office or Precinct Committeeman in Arizona, one must submit a Nomination Paper Declaration of Qualification stating, "I will have been a citizen of the U.S. for (#) years before my election and have been a citizen of Arizona for (#) years before my election" — never mentioning foreign citizenship;

Whereas the Citizenship Requirement is therefore singular and exclusive;

Whereas elected officials "solemnly swear or affirm [to] bear true faith and allegiance to the Constitution of the U.S. and the Constitution and laws of Arizona" — likewise singular and exclusive;

Whereas the Naturalization Oath of Allegiance to the United States — "I hereby declare, on oath, that I absolutely and entirely renounce all allegiance and fidelity to any foreign state of which I have heretofore been a subject or citizen" — is inherently incompatible with the notion of dual citizenship; and

Whereas "dual citizens" taking an oath of office to serve and represent Arizona government elective offices or Precinct Committeeman and State Committeeman positions while simultaneously claiming partial allegiance or "belonging" to a foreign nation is absurd on its face; now therefore be it

Resolved, that the AZGOP hereby commits to uphold and promote the principle that only U.S. Citizens possessing singular U.S. citizenship shall be eligible and qualified for Arizona Elective Office, Precinct Committeeman, and State Committeeman.

**PROPOSED RESOLUTION 8**

**RESOLUTION 1 and RESOLUTION 5 combined to make RESOLUTION 8**

**Status in Committee: FAILED 6-7-0**

**RESOLUTION TITLE: Resolution to Restore and Protect Election Integrity in All State and Federal Elections Held in Arizona**

**RESOLUTION:**

WHEREAS, public confidence in Arizona's elections has been undermined by electronic voting systems, voting centers, and delayed ballot counting, and

WHEREAS, paper ballots with secure chain-of-custody, security markings, and hand counting at the precinct provide the most transparent and reliable method of tabulation, and

WHEREAS, President Donald J. Trump and Republican Party of Arizona affirm that election integrity is essential to preserving representative government and support policies and legislators committed to securing Arizona's elections;

NOW, THEREFORE, BE IT RESOLVED, that the Republican Party of Arizona calls for the elimination of voting centers and the full restoration of precinct-only voting for all elections; and

BE IT FURTHER RESOLVED, that all ballots cast in Arizona elections include but are not limited to the following actions:

- Support election integrity legislation by authorizing hearings with subpoena and criminal referral authority.
- Requiring hand-marked, hand-counted paper ballots at secure local precincts of no more than 1000 voters.
- Limited absentee voting to clearly defined eligibility.
- Ensuring all ballots are fully counted and accounted for on Election Day.

**PROPOSED RESOLUTION 8 CONTINUED:**

BE IT FURTHER RESOLVED, that all elected officials are called upon to uphold these principles to restore public trust in Arizona's electoral process and preserve the integrity of our republic, and

BE IT FINALLY RESOLVED, that this resolution be transmitted to all members of the Arizona Legislature, the Governor, the Secretary of State, and all County Board of Supervisors, with the expectation that legislation and administrative rules be adopted immediately to implement these standards.
